Categories of Membership:

Regular: Licensed customs brokers, licensed foreign freight forwarders, NVOCC and/or IATA cargo agents in the State of Florida.

Associate: Registered indirect air carriers, steamship companies, airlines, trucking firms, railroad firms, stevedores, terminal operators, port associates and port authorities, transportation insurance companies serving the community of customs brokers and foreign freight forwarders, banks, international trade lawyers, Importers and Exporters.

Fee \$325 per year.

Affiliate: Transportation organizations/associations (not transportation companies) and Chambers of Commerce

Honorary: An honorary membership may be conferred upon any person who, in the opinion of the Board of Directors, has rendered an outstanding contribution to the customs brokerage and/or foreign freight forwarding industry.

Annual dues are not prorated or refundable. Membership period is January 1st thru December 31st. New members who join our Association during last quarter of the calendar year will not have renewal fees assessed for the first full year. Renewal fees will be assessed for each year thereafter. Annual dues will be billed in the month of September of every year. **If you wish not to re-new your membership the offices of FCBF must be notified in writing 15 days prior to the yearly billing cycle which commences in September of every year, verbal notification of cancellation or non-renewal will not be accepted.**
